3. Boy's & Girl's Club of Franklin agrees to provide the City with a certificate of insurance showing and delineating the City as an additional insured for purposes of liability coverage, with said insurance coverage to be no less than One Million Dollars (\$1,000,000.00). Further, the Boy's & Girl's Club of Franklin agrees to hold the City harmless upon and to indemnify the City fully against any and all liability, claims, actions, demands, costs, and expenses (including but not limited to attorney fees, litigation costs, and expert witness fees and expenses) directly or indirectly arising from the conduct, operation, business practice, omissions, or establishment of the Boy's & Girl's Club of Franklin.
