# RESOLUTION APPROVING INTERLOCAL AGREEMENT BETWEEN CITY OF FRANKLIN, INDIANA AND FRANKLIN UNION NEEDHAM TOWNSHIP, JOHNSON COUNTY, INDIANA PROVIDING FUNDING FOR PURCHASE OF EQUIPMENT

WHEREAS, the City of Franklin, Indiana, desires to purchase certain water rescue fire equipment; and

- WHEREAS, the City of Franklin believes that the purchase of said equipment is in the best interest of its citizens and will promote the public health safety and welfare of Franklin Residents; and
- WHEREAS, the City of Franklin, through a separately executed Interlocal Agreement does provide fire service to residents of Franklin Union Needham Township, Johnson County; and
- WHEREAS, Franklin Union Needham Township, Johnson County, Indiana has available to it funding to assist with the purchase of the water rescue fire equipment; and
- WHEREAS, the parties have reached an Agreement pursuant to the proposed attached Interlocal Agreement identified as Exhibit "A"; and
- **WHEREAS,** I. C. 36-1-11-8 authorizes transfer or exchange of property, including funds between governmental entities upon terms and conditions agreed upon by the parties as evidenced by the adoption of substantially identical resolutions by the governing body of each entity; and
- WHEREAS, Franklin Union Needham Township has agreed that it shall provide the sum of Twenty Seven Thousand Seven Hundred and Twelve Dollars (\$27,712.00) to help defray the cost of the water rescue fire equipment as identified in the Interlocal Agreement;
- WHEREAS, the City of Franklin Board of Public Works and Safety has recommended approval of the Interlocal Agreement with Franklin Union Needham Township, Johnson County, Indiana with its appreciation and recognition of the assistance provided by the Township Trustee and Advisory Board.
- WHEREAS, said recommendation is subject to approval by the City of Franklin Common Council.

**NOW THEREFORE**, the undersigneds do authorize as follows:

- 1. The City of Franklin Common Council agrees that approval of the Interlocal Agreement with Franklin Union Needham Township is in the best interests of the City of Franklin.
- 2. The City of Franklin shall enter into the Interlocal Agreement as presented on the attached "Exhibit A".
- 3. Further, the Mayor, on behalf of the City of Franklin, is authorized to take all actions necessary to record the Interlocal Agreement as provided by its terms and conditions.
- 4. Further, the City of Franklin Clerk Treasurer is authorized to accept the sum of Twenty Seven Thousand Seven Hundred and Twelve Dollars (\$27,712.00) from Franklin Union Needham Township and is authorized to pay the sums for the purchase of water rescue fire equipment.

### INTERLOCAL AGREEMENT BETWEEN

# CITY OF FRANKLIN, INDIANA AND FRANKLIN UNION NEEDHAM TOWNSHIP, JOHNSON COUNTY, INDIANA TO PROVIDE FUNDING FOR PURCHASE OF EQUIPMENT

THIS INTERLOCAL AGREEMENT ("Agreement") is made and entered into this day of \_\_\_\_\_\_\_, 2025, between the City of Franklin, Indiana, by and through its Board of Public Works and Safety and Common Council, a municipality organized and formed under the laws of the State of Indiana ("City") and Franklin Union Needham Township, Johnson County, Indiana, by and through its representative agent the Franklin Union Needham Township Trustee and Franklin Union Needham Township Advisory Board ("Township").

WHEREAS, the City provides fire protection services to all City residents as well as to residents within the Township pursuant to a separate Interlocal Agreement; and

WHEREAS, the Township has indicated a desire to assist the City in the purchase of certain water rescue fire equipment; and

WHEREAS, the City desires to purchase said new fire rescue equipment so that it may be placed within the City's inventory of available firefighting equipment; and

WHEREAS, the City and Township believe that having this additional equipment available to the City and public safety officers will result in the potential saving of lives and is in the best interest, health, safety and welfare of the residents of both the City and Township; and

WHEREAS, there is a cost to purchase this additional equipment; and

WHEREAS, the Township, has determined that it has funding available to assist with the costs of this equipment; and

WHEREAS, the Township has determined that it has available funding in the amount of Twenty Seven Thousand Seven Hundred and Twelve Dollars (\$27,712.00) to help defray the costs of said equipment; and

WHEREAS, the City of Franklin wishes to accept said funding for the specific purpose of purchasing said equipment; and

WHEREAS, attached to this Interlocal Agreement as Exhibit "A" is a list of the equipment to be purchased and the costs associated with said equipment.

**NOW THEREFORE**, in consideration of the agreements, mutual covenants and promises set forth herein, and each act done pursuant hereto by each of the Parties, it is hereby agreed by and between the Parties as follows:

- 1. The Township agrees to pay to the City of Franklin the sum of Twenty Seven Thousand Seven Hundred and Twelve Dollars (\$27,712.00) which sum shall be used by the City for the sole purpose of purchasing water rescue equipment, as identified on the attached Exhibit "A", to be owned by the City of Franklin and utilized by its public safety officers and fire fighters in furtherance of protecting the public health safety and welfare of citizens.
- 2. The City of Franklin shall provide the Township with a copy of the purchase order and payments made to purchase the equipment.
- 3. The City of Franklin and the Township shall each pass substantially similar Resolutions approving this Interlocal Agreement.
- 4. This agreement shall be recorded in the Office of the Recorder of Johnson County, Indiana and filed with the Indiana State Board of Accounts within sixty (60) days of execution which shall be defined as approval of this agreement by both the City and Township representatives.
- 5. This agreement shall be effective upon the occurrence of all of the following:
  - (a) Signing by the parties hereto:
  - (b) The passage of appropriate resolutions and recordation of this agreement with the Johnson County Recorder; and
  - (c) The filing of this agreement with the Indiana State Board of Accounts, Johnson County Auditor and Auditor of the State.
