Summary:

1. On May 16^{th,} 2022, the Franklin Common Council passed Resolution No. 2022-10, approving a 10-year tax abatement with a 5% economic development fee on personal property for NSK Precision America, located at 3450 Bearing Drive.

2. Actual and estimated benefits, as projected for 2024:

- 3. The company indicated on their SB-1 that they would add \$7,183,000 investment in personal property to their facility. In 2022, the work is just beginning, and the full investment will be shown in the next 2 compliance reports. In 2023, the company invested \$357,186 and is on track to complete the investment on time. In 2024, they increased their investment and will continue in 2025.
- 4. In 2022, the company was 62 employees short. In 2023, they were down by 19, but wages are up significantly. They are on track to be at full employment by the deadline of 2026. In 2024, they were still down in employment but up in wages.
- 5. The completion date approved on their SB-1 Form is March 31, 2026. The personal property tax abatement is scheduled to expire in tax year 2036 payable in 2037. Their last year for compliance review will be 2036.
