 - a. Public Education and Outreach:
 - * Public Survey is included on City website only nine (9) responses to date To be redone in association with SW rate implementation December 2008.
 - * City has met with both the Johnson Co. Solid Waste District and SWCD and is developing a MOU to coordinate shared public education initiatives.
 - * City is reconstructing its MS4 website projected to be complete August 31, 2008. (Major updates made by 7-31-08)
 - * Storm labeling program is approximately 30% complete. City requires all new inlets to be precast labeled.
 - b. Public Involvement and Participation:
 - * Updates to City Council & Board of Public Works are provided on a regular basis tied to issues associated with the 6-7-08 flood.
 - * Storm labeling of existing SW inlets is being discussed as a cooperative projects with JCSWD & JCSWCD Project is highlighted on SWCD's webpage.
 - * Annual public participation in stream clean up, much associated with after flood clean up efforts.
 - c. Illicit Discharge Detection and Elimination:
 - * IDDE Ordinance adopted December 2006
 - * City utilitzes the 2003 IDDE Handbook for Municipalities as developed by the New England Interstate Water Pollution Control Commission at its technical program manual.
 - * Wastewater treatment facility Labortory Director has been designated as the IDDE Coordinator.
 - d. Construction Site Storm Water Run-off Control:
 - * Site Construction & Post Construction Storm Water Control Ordinance was adopted December 2006.
 - * Administrative procedures for permitting have been developed and City has initiated the process with its first facility, (Cooper Tire) July 2008.
 - * City Staff has attended IDEM sponsored training Spring 2008.
 - Post-construction Storm Water Management in New Development and Redevelopment:
 - * Site Construction and Post Construction Storm Water Control Ordinance was adopted December 2006.
 - * Technical standards program is being developed. Currently the City is utilizing the Indiana SW Manual and will employ practice with its initial permitting activity associated with Cooper Tire facility July 2008.
 - f. Pollution Prevention and Good Housekeeping for Municipal Operations:
 - * Street Sweeping The Franklin Street Department is responsible for implementing the community street sweeping program which is conducted continuously generally from April through October. Records are being developed for tracking quantative factors to measure the effectiveness of this program. Program development was delayed due to a shift in resources associated with the June 2008 flood. Procedure is projected to be in place by the 4th Quarter of 2008.
 - * Storm Drain System Cleaning The Franklin Street Department cleans storm drains as needed. The June 2008 flood has significally impacted this program and consequently changes are expected during the 4th Quarter of 2008.
 - * Secondary Contained of Fueling Facility All existing above ground municipal owned fueling facilities have secondary contained which is monitored on a regulas basis.
 - * Sidewalks and Parking Lots The City provided litter recepticles in high traffic areas and implores anti-littery lows.
 - * Pesticide Management The City Parks Department produces pesticide "green" storage and application management practices to assure proper handling and product utilization consistant with the State Chemical Office directives.
