## A COMMON COUNCIL BUDGETARY ORDINANCE AUTHORIZING AN ADDITIONAL APPROPRIATION OF \$1,000,000 IN THE RAINY DAY FUND

WHEREAS, the Hazard Mitigation Grant Program (HMGP) and Community

Development Block Grant (CDBG) funds for the implementation of the City of Franklin

Acquisition Project are received approximately 45 days after the submittal of a draw down request to the Indiana Department of Homeland Security, and

WHEREAS, monies are needed to cover the costs of completing the Acquisition Project in an expeditious manner;

THEREFORE, be it ordained by the Common Council of the City of Franklin, Johnson County, Indiana, that \$1,000,000 is hereby appropriated into the Rainy Day Fund and for the purpose specified, subject to the laws governing same, with the understanding that these funds will be reimbursed from the HMGP and CDBG monies upon receipt.
