BUDGETARY ORDINANCE No.: 11-02

ADDITIONAL APPROPRIATION ORDINANCE

WHEREAS, it has been determined that it is now necessary to appropriate more money than was appropriated in the Motor Vehicle Highway Fund 2011 annual budget for Other Services to cover \$202,716 of reimbursable expenses, and \$72,684 matching funds in the Highway Safety Improvement Program (HSIP) Sign Replacement Grant for the remainder of the year; now therefore:

Sec.1. Be it ordained by the Common Council of City of Franklin, Indiana that for the expenses of the taxing unit the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to the laws governing the same:
